HOLD HARMLESS AGREEMENT

- 1) **Hold Harmless**: Upon Participant's taking part at HSD by their employees, agents, invites, volunteers, and students for the purpose of their involvement with HSD, Participant shall hold harmless and indemnify RTP and HSD, from every liability, claim or demand, made by reason of:
 - a.  - b. For the use of any copyrighted or un-copyrighted composition, Tahitian cultural sacred protocol, patented or unpatented invention, article, or appliance during HSD.
 - c. For the use of their image (s) or likeness for advertising purposes and allows HSD to videotape and photograph their performance or presence at HSD for their archives and use within HSD videotape, website and all other related media.
 - 2) **Authority to Enter Agreement:** Each Participant warrants that the individual who signs this document has the legal power, right, and authority to make this Agreement and bind each respective Participant.
 - 3) **Amendment: Modifications:** No supplement, modification, or amendment of this Agreement shall be binding unless executed in writing and signed by both Parties.
 - 4) **Attorneys' Fees and Costs:** In the case of legal action or other proceedings due to breech of this agreement, the successful or prevailing Party shall be entitled to recover reasonable attorneys' fees and other related costs.
